[How to Use This Sheet]

We exert constant efforts toward the control of substances of our products and the disclosure of information to our customers. In accordance with the laws and regulations in Japan, we have also provided information to our customers in the form of SDS. However, in accordance with regulations in other countries, and also from the standpoint of green procurement, we are beginning to receive increasing numbers of requests for detailed information about contents of specified chemical substances. As SDS, in the form prescribed in Japan, cannot provide such detailed information, we have prepared this Information Sheet for the purpose of complementing SDS.

[Investigation of Contents of Specified Chemical Substances in the Product]

This investigation has been conducted about those chemical substances which are listed in the Joint Industry Guide prepared through collaboration between JGPSSI, EIA, and EICTA.

Afterwards, JGPSSI has revised it largely, considering latest trend of the regulations, so finally has issued JIG-101 Ed 4.1 in January, 2012. The subject chemical substances and the results of this investigation are shown in the attached sheet hereto.

[Cautions]

- (1) The investigation results were based on the JIG criteria, and we cannot ensure the contained amount for individual products.
- (2) Letters R, A and I in the criteria columns in the above table show that the substances are "regulated", "for assessment only", and "for information only", respectively. Refer to JIG-101 Ed 4.1 for precise definitions.
- (3) There are roughly four types of expression in the threshold level columns for handling the denominators when calculating the concentration of content with respect to the threshold "intentionally added", "by weight of homogeneous material", "by weight of product", and "by weight of material".

As to "intentionally added", whether the substance was intentionally added or not is literally judged to determine presence or absence of the substance. As to "by weight of homogeneous material", the concentration of content is calculated using the respective denominators of the base steel and surface coating (including both of plating and chemical treatment layer), and compared with the threshold to determine whether the substance is contained or not.

As to "by weight of product" and "by weight of material", the product and material are synonymous for steel products, so in both cases, the entirety of steel material, i.e. a unit of the base steel and surface coating (including both of plating and chemical treatment layer), is set to a denominator: The concentration of content is calculated using this denominator and compared with the threshold to determine whether the substance is contained or not.
